



4. FORM OF CERTIFICATION OF APPLICANTS FOR HIGHER EDUCATION

Attestation of graduates of the educational programme of the specialty D3 "Management" is carried out in the form of a public defense of the qualification thesis and is completed by issuing a document of the established sample on awarding him/her a bachelor's degree with the assignment of the qualification: bachelor of management.

The qualification thesis involves solving a complex specialized task or practical problem in the field of management, characterized by complexity and uncertainty of conditions, with the application of theories and methods of economic science.

The qualification thesis is checked for academic plagiarism, which includes automated checking using software tools and analysis of works by specialists in the relevant subject area, taking into account the results of such a check. The results of the check are displayed in the form established by the department.

The qualification thesis must be published in the university repository.

The publication of qualification theses containing information with limited access is carried out in accordance with the requirements of the law.

The public defense of the qualification thesis is held at an open meeting of the attestation commission.


